
PFCLG MEETS WITH LEGISLATORS

Partnership for Children of Lincoln & Gaston Counties'
Travel to Raleigh to Ask Gaston and Lincoln County Legislators
to Maintain Investments in Early Childhood Programs.



On Tuesday, May 22, child advocates from Lincoln and Gaston Counties traveled to the North Carolina General Assembly as part of Smart Start's statewide "Tuesdays for Tots" initiative. The constituents met with the legislative delegation from each county and asked members to restore \$18.8 million to Smart Start. In 2011, Smart Start funding was reduced by 20% (\$37.6 million), disproportionately more than any other component of the education system. As a result thousands of children are no longer benefiting from much-needed early childhood programs. "There are only 2,000 days between the time a baby is born and when that child shows up for the first day of kindergarten," said Michael Linker, Executive Director of the Partnership for Children of Lincoln & Gaston Counties. "We're meeting with legislators to discuss the needs of children in our community, the research that supports programs like Smart Start, and why investing in our youngest citizens is a wise investment for families, the economy and our society as a whole." State funding for Smart Start has been cut by \$80 million over the last decade. These cuts are occurring at the same time that economists, military leaders, law enforcement and business leaders are advocating that investments in young children are one of the strongest investments for sustained growth and job creation, protecting our national security, and providing children with the opportunity to reach their potential.

Local residents traveling to the North Carolina General Assembly included: Michael Linker, Executive Director of the Partnership for Children of Lincoln & Gaston Counties, Amy Wadsworth, Public Information Coordinator of the Partnership for Children of Lincoln & Gaston Counties, and Amy Simmons, Director of the Grace School in Stanley and PFCLG Board member. The group met with the following members of the Lincoln and Gaston County legislative delegation. They included Representative William A. Current, Sr., Representative Kelly E. Hastings, Representative John A. Torbett, Representative Jason Saine, Senator Chris Carney and Senator Kathy Harrington.



WATER SAFTEY

Summer is a great time to spend outdoors, especially at the beach or lake. It's important to keep safety in mind, when children are around water. You should always know where your child is at all times. Do not be distracted by phone calls, text messaging, reading or talking to others. Jim Landis, Safe Kids Gaston County Coordinator/Gastonia Fire Educator said parents should enroll children in swimming lessons at a young age so they can learn to swim. Also, parents should learn CPR (Cardiopulmonary resuscitation), which can restore circulation of oxygen-rich blood to the brain. Without oxygen, permanent brain damage or death can occur in several minutes. Other tips include making sure gates are latched/closed around the pool area and double checking that the drain cover on a pool is compliant. During the summer months last year (June-September 2011), there was one near drowning incident that was treated at CaroMont Health, that is a 50 percent decrease from the previous year. However, the Trauma Services Department warns to not let your guard down! Landis said drowning's can occur in water less than 1 to 2 inches such as a bucket of water. Empty all buckets and containers immediately after use. Store them upside down! Keep doors to bathrooms and laundry rooms closed around the house. Also, keep toilet lids closed and use toilet locks. Once bath time is over, drain the tub!

Other tips at the pool/lake:

- Always follow the rules at the pool, they help keep you safe.
- Wear a lifejacket if you do not know how to swim.
- Never play in or near water alone. Only go to a pool if a grownup is with you.

Want to learn CPR?

Contact your local health department, or local American Red Cross chapter that offer courses. For swimming lessons, contact your local parks and recreation department or your local YMCA.
